



Privacy Notice

At KMC, we are in touch with our customers and we understand the importance of your privacy. We provide this notice to explain our online information practices and the choices you can make about the way your information is collected and used. This notice applies to all information collected or submitted on the KMC web sites.

By using any of our web sites, or any application therein, you affirm that (1) you are of legal age and have the necessary purchasing and legal authority to bind your company to any applicable transactions, and (2) you have read this Policy and consent to the use of collected personal information as described in this Policy.

The Information We Collect:

KMC uses this collected data to measure site performance and plan improvements to design and usability.

On some pages, you can order products, submit inquiries, register to receive information materials, or register for continuing education and training. We will only ask for information that is reasonably necessary to provide the requested information or service. Information collected may include:

- Name (personal and company)
- Address (billing and shipping)
- Email address
- Phone and Fax Numbers
- Purchase order and business document Information

On some pages, you can submit information about other people. For example, if you register an employee for a class, you will need to submit both the student's contact information and your own.
